DESCRIPTION

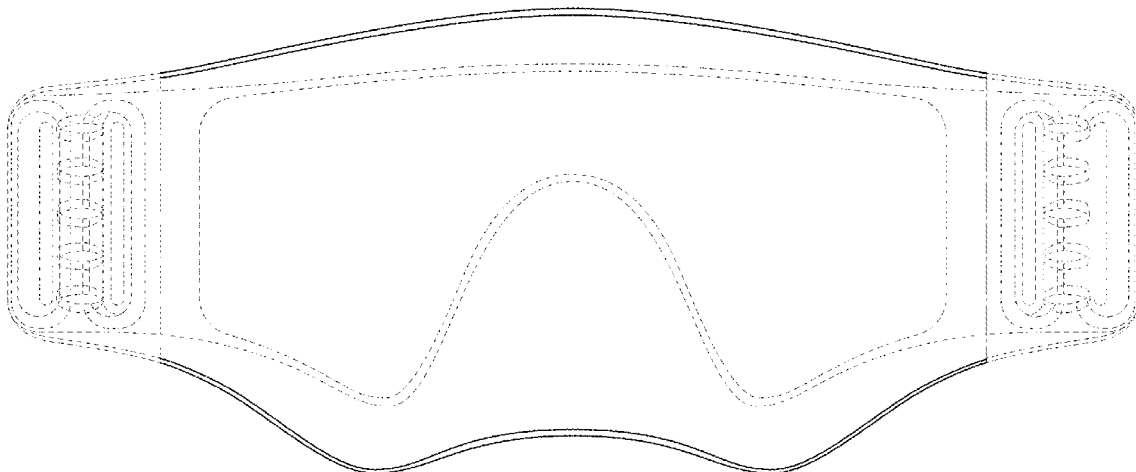
FIG. 1 is a front elevation view of eye shades showing our new design;
FIG. 2 is a rear elevation view thereof;

FIG. 4 is a bottom view thereof;
FIG. 5 is a right side elevation thereof;
FIG. 6 is a left side elevation view thereof;
FIG. 7 is a front perspective view thereof; and,
FIG. 8 is a rear perspective view thereof.
The broken lines shown in the drawings are included for the purpose of illustrating unclaimed portions of the eye shades and form no part of the claimed design.
The dash-dot-dash lines shown in FIGS. 1 and 3-8 represent an unclaimed boundary between claimed and unclaimed features. None of the broken lines form any part of the claimed design.

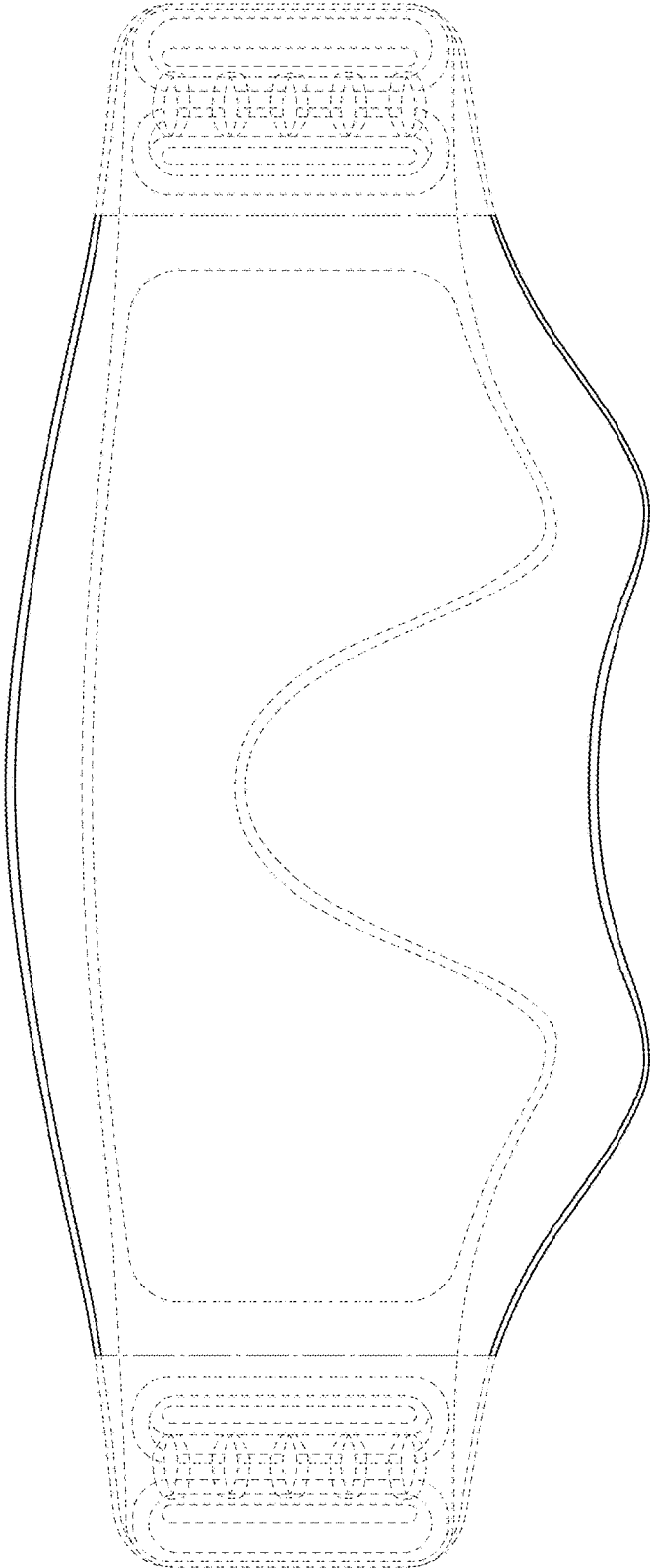

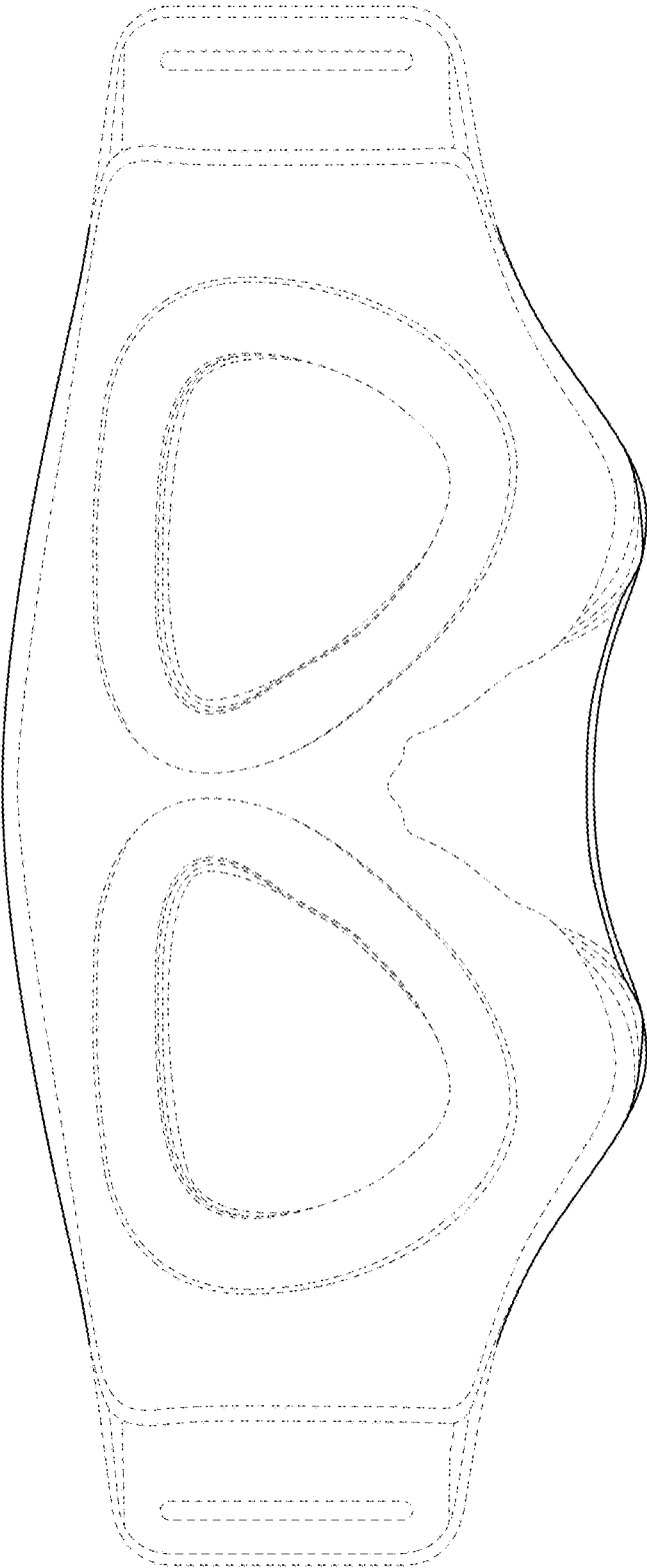

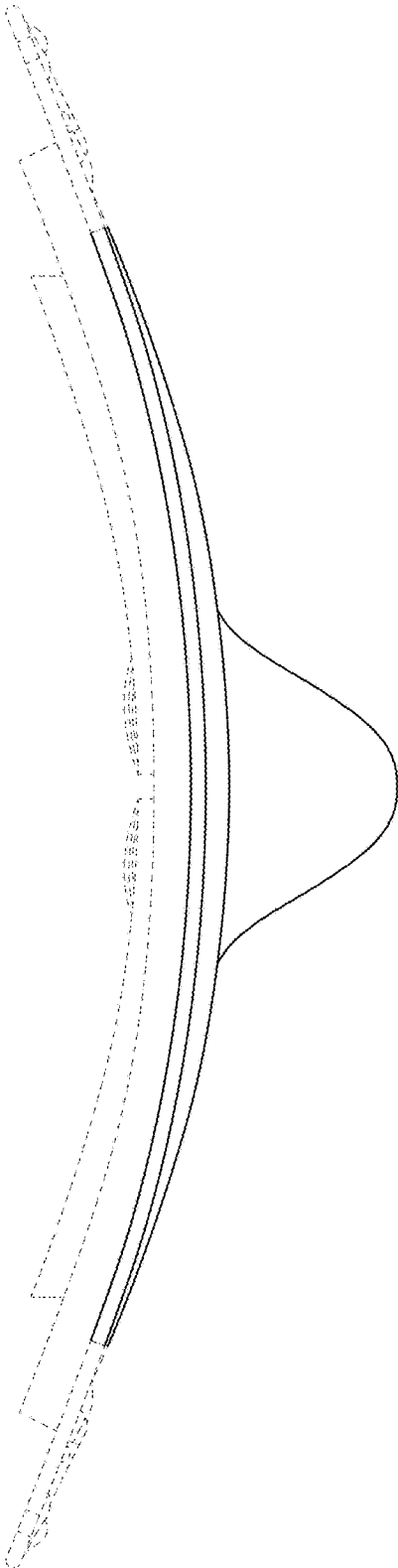

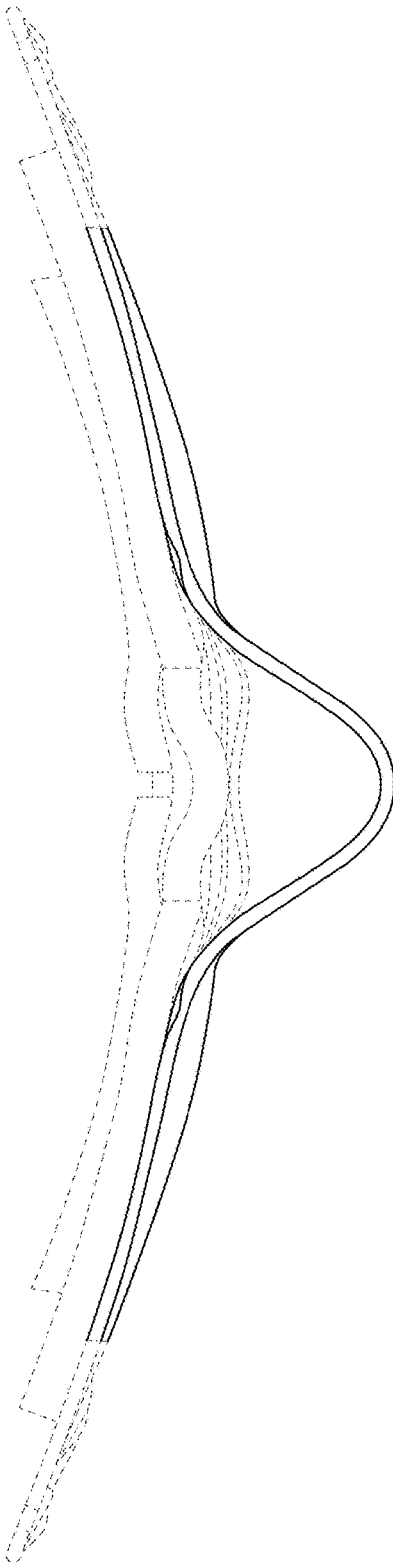

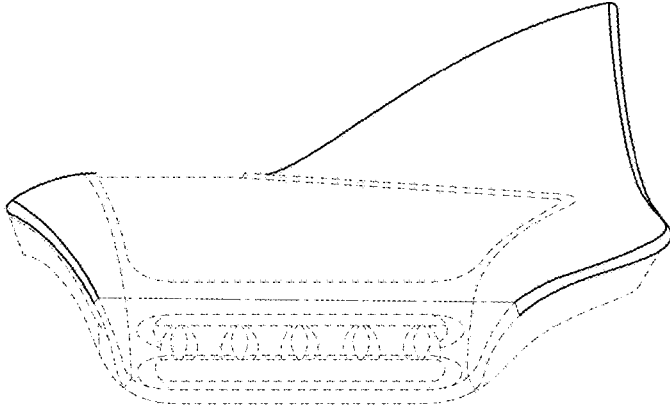

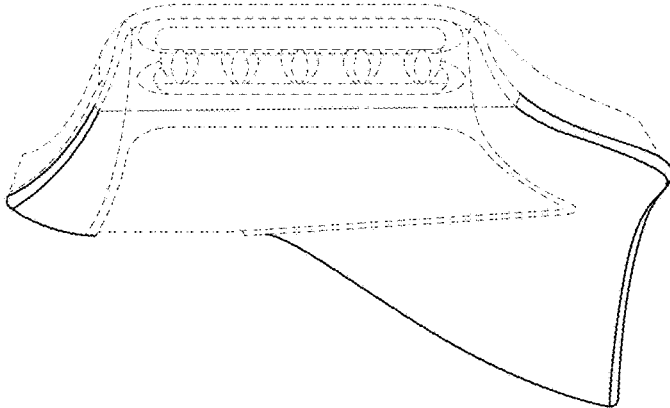

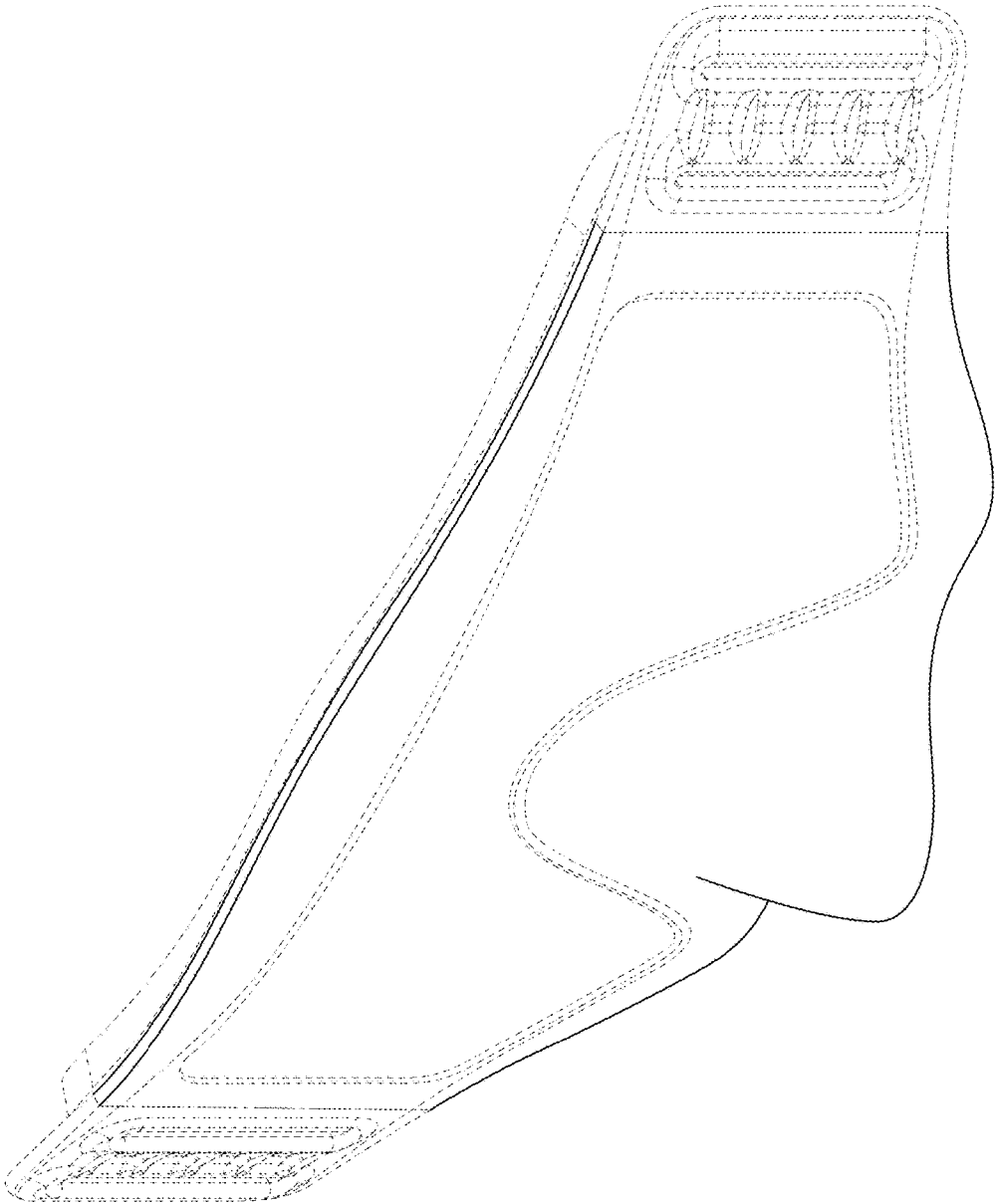

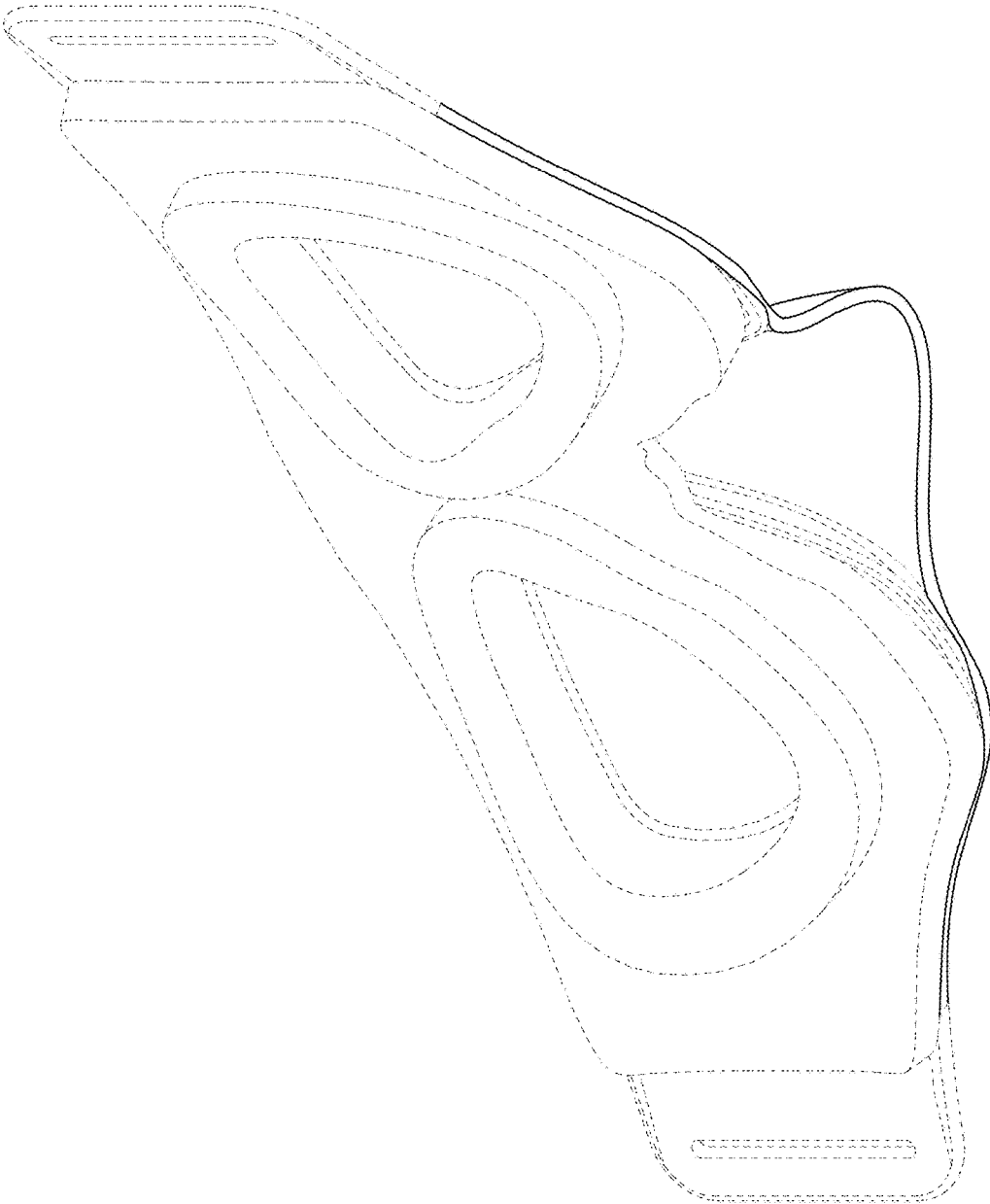
